In addition, I hereby (i) expressly waive and release any and all claims against the Chamber and its officers, directors, employees, agents, and affiliates (collectively “Releasees”), on account of injury, illness, disability, death, or property damage arising out of or attributable to the Activity, whether caused by the Chamber or any other Releasee or otherwise, (ii) covenant not to make or bring such claim against the Chamber or any other Releasee, and (iii) forever release and discharge the Chamber and all other Releasees from liability under such claims.
